I am responsible for the return of this equipment in the same state in which I received it. I agree to pay in full for any repairs or replacement if the equipment is damaged or lost. Late returns will be charged at \$70 US per day. **I understand that I will need to complete the Equipment Checklist and Waiver Form in Belize.**

I AM AWARE THAT SEA KAYAKING IS A DANGEROUS SPORT AND I AM AWARE OF THE DANGERS OF KAYAKING. I UNDERSTAND THAT IEC IS IN NO WAY RESPONSIBLE FOR MY SAFETY OR THE SAFETY OF THE EQUIPMENT I AM RENTING. I understand that IEC makes no warranty as to the fitness or suitability of the equipment. I am fully responsible for my own safety and for the equipment. _____ (initial)

I agree to assume all risks in connection with the use of the equipment, whether foreseen or unforeseen and whether or not caused by the fault or negligence of IEC and/or its employees. I also agree to release IEC and/or its employees from all liability for any harm, injury or damage, which may befall myself or the equipment I rent. I also agree to indemnify and save and hold harmless IEC and/or its employees from any claim by me, my family, estate, heirs, assigns or any third party arising out of my rental of the equipment.

I have had all medical examinations I believe are necessary to assure of and assume responsibility for my physical fitness and capability to use the equipment.

I agree to repair or replace in a manner acceptable to IEC any of the equipment damaged while I am renting it. If I fail to repair or replace such equipment in an acceptable manner, I will pay IEC the cost incurred in repairing or replacing the equipment as determined by IEC.

I further state that I am of lawful age and legally competent to sign this agreement. I also understand that this is a contract and not a mere recital, and I agree I have signed this contract as my own free act.

CANCELLATIONS AND REFUNDS

Our cancellation policy is as flexible and understanding as possible. All our bookings are received well in advance of trip departures and other people may have been turned away because kayaks have been reserved. All cancellations must be received at our Canadian office in writing and refunds will be issued according to the following schedule:

- 60 days or more prior to departure, \$200 deposit is retained
- 59-45 days prior to departure 70% refund
- 44-30 days prior to departure 50% refund
- 0-29 days prior to departure the full amount is retained
